INCOME TAX INFORMATION

I understand if any utility bill is unpaid by the time of the next utility billing, it shall be considered delinquent and procedures for shutoff of the utility services will be instituted 15 days after the account is first delinquent. A copy of the Oak Harbor Utilities regulations concerning nonpayment discontinuance of utility services may be obtained from the utility billing office. In consideration for the furnishing of utility services to the property for which application is made, the undersigned accepts responsibility for the payment of all utilities furnished, whether it is occupied by the owner or by someone else.
