

ORDINANCE NO. 13-2017

AN ORDINANCE AMENDING ORDINANCE NO. 2 - 2017 TO MAKE APPROPRIATIONS AND OTHER EXPENDITURES FOR THE VILLAGE OF OAK HARBOR, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2017 AND DECLARING AN EMERGENCY.

WHEREAS, on March 20, 2017, Council of the Village of Oak Harbor adopted Ordinance No. 2 - 2017, entitled An Ordinance to Make Appropriations For Current Expenses And Other Expenditures Of The Village of Oak Harbor, State of Ohio, During the Fiscal Year Ending December 31, 2017; and

WHEREAS, the Village Fiscal Officer has advised Council that it may be necessary to amend the appropriation to adjust for fourth quarter expenditures; and

WHEREAS, it is necessary to amend Ordinance No. 2 - 2017, and said action is hereby determined to be an emergency measure, necessary for the immediate preservation of the health, safety and welfare of the citizens of the Village, and as such, shall be effective immediately, upon due authentication by the Mayor and Fiscal Officer; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF OAK HARBOR, OTTAWA COUNTY, OHIO:

Section 1. That Ordinance No. 2 - 2017 entitled An Ordinance To Make Appropriations For Current Expenses And Other Expenditures Of The Village Of Oak Harbor, State of Ohio, During Fiscal Year Ending December 31, 2017 And Declaring An Emergency hereby is amended as follows:


