ORDINANCE NO. 14 - 2015

AN ORDINANCE REPEALING AND AMENDING CERTAIN UTILITY ORDINANCES REGARDING EQUIVALENCY FACTORS AND OTHER RELATED SECTIONS OF THE CODIFIED ORDINANCES OF OAK HARBOR

WHEREAS, the Village Administrator, the Village Utility Departments and the Village Administration has reviewed the billing structure of the Oak Harbor utilities and determined that the structure needs updating; and

WHEREAS, the updated billing structure will more fairly assess charges to all customers of the Oak Harbor utilities; and

WHEREAS, the updated billing structure will allow the Oak Harbor utilities to become more efficient in its delivery of services.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OAK HARBOR, OTTAWA COUNTY, OHIO:

Section 1.

Section 50.072 of the Codified Ordinances of Oak Harbor shall be repealed in its entirety and replaced with Exhibit "A".

Section 2.

Section 52.52 of the Codified Ordinances of Oak Harbor shall be amended to add Section 52.52(B)(3)(a). The new Section 52.52(B)(3)(a) is attached hereto as Exhibit "B". All other sections of Section 52.52 shall remain in full force and effect, except Schedule 1 ESR which may have been adopted by the Board of Public Affairs is hereby repealed.

Section 3.

Section 52.521 shall be created and added to the Codified Ordinances of Oak Harbor. Section 52.521 shall read as set forth in Exhibit "C".

Section 4.

Sections 53.002(H)(1), 53.002(H)(2), 53.002(I), 53.002(J)(1), 53.002(J)(2), and any and all residential water service schedule (RWS) and commercial water service schedule (CWS) which may have been enacted by the Board of Public Affairs are hereby repealed.

Section 5.

Section 53.002(H) shall be enacted as set forth in Exhibit "D".

Section 6.

The current Section 53.012 shall be repealed in its entirety and replaced with §53.012 as set forth in Exhibit "E".

Section 7.

The current Section 53.089 shall be repealed in its entirety and replaced with §53.089 as set forth in Exhibit "F".

Section 8.

The current §53.090 shall be repealed in its entirety and replaced with §53.090 as set forth in Exhibit "G".

Section 9.

Section 54.02 as set forth in Exhibit "H" shall be enacted.

Section 10.

This Council hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of this Council, and that all deliberations of Council, and of its committees, which result in formal action, were taken in full compliance with the applicable legal requirements.

Section 11.


That this Ordinance shall take effect and be in full force and effect after the earliest date allowed by law.
