

**ORDINANCE NO. 15-2015**

**AN ORDINANCE AMENDING ORDINANCE NO. 03-2015 TO MAKE APPROPRIATIONS AND OTHER EXPENDITURES FOR THE VILLAGE OF OAK HARBOR, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2015 AND DECLARING AN EMERGENCY.**

**WHEREAS**, on March 16, 2015, Council of the Village of Oak Harbor adopted Ordinance No. 03-2015, entitled An Ordinance to Make Appropriations For Current Expenses And Other Expenditures Of The Village of Oak Harbor, State of Ohio, During the Fiscal Year Ending December 31, 2015; and

**WHEREAS**, the Village Fiscal Officer has advised Council that it may be necessary to amend the appropriation to adjust for fourth quarter expenditures; and

**WHEREAS**, it is necessary to amend Ordinance No. 03-2015, and said action is hereby determined to be an emergency measure, necessary for the immediate preservation of the health, safety and welfare of the citizens of the Village, and as such, shall be effective immediately, upon due authentication by the Mayor and Fiscal Officer; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF OAK HARBOR, OTTAWA COUNTY, OHIO:**

Section 1. That Ordinance No. 03-2015 entitled An Ordinance To Make Appropriations For Current Expenses And Other Expenditures Of The Village Of Oak Harbor, State of Ohio, During Fiscal Year Ending December 31, 2015 And Declaring An Emergency hereby is amended as follows:
